- _____ If my teen is in an uncomfortable or unsafe situation involving alcohol or illicit drugs, I agree to come and pick him or her up, regardless of the time or place. If it is not possible, I will pay for a taxi to bring my teen home safely. There will be no argument at that moment, but a discussion of such an incident will follow at a later time.
